RANGER EDUCATION

This little educational process took place when a couple of USFS Rangers visited the campsite of one of our members camped on one of the Genesee claims. One of them was obviously in the know of the Mining Law, while the other wasn't, none-the-less charged with enforcing the Law. Actually both were wrong in this specific incident.

In context, as I heard the story from the member, one Ranger asked the other, how long can this miner camp on his claim? The other responded 14 days. The first Ranger said wrong. The miner can camp on his claim all year long providing it is incidental to working his claim. So

Ranger one knows the law and Ranger two doesn't, however she didn't know our NOI "terms of use". An educational process performed one being partially correct and the other not knowing.

In pure understanding of the Law, Ranger one was correct and Ranger two was incorrect. However there are other specific rules and regulations that come into play as to what can be done and what cannot be done on a mining claim. So as it boils out they were both wrong. Ranger two didn't have a clue, and Ranger one only cited the basic law, and didn't know the specifics of the UPI filing. God Bless Ranger one. She at least knew the basic Law.

CLAIMS

What can and cannot be done on a mining claim is spelled out in how the claim is filed. There are a number of ways a claim can be filed. Regardless of how it is filed, unless the pure intent is to prospect only a statement of use of how it will be mined, must be made. Prospect only is to work up and down the claim looking for what may be the big glory hole or the newest big discovery in the Mother Lode area, no tree cutting and no "earth moving" equipment.

Nor does it include a "large group of people" "prospecting". Possible major surface disturbance may occur with large numbers of people.

(Public Lands for the People) process, a NOI must be filed. This is not the law as it stands, as of this writing, and this USFS concept of the law is being fought.

The previously presented information primarily pertains to Mom and Pop or individual claimants, or a very small group of claimants. UPI as an organization, and a claimant, having 400 plus members has to look at the claiming process from a totally different perspective.

Imagine in your mind what kind of damage to the land could take place if our entire group decided to spend the entire year mining at our largest claim, Genesee. Major surface disturbance would occur. Grassy and brushy trails would become super highways to the Au providing areas of the claims.

Very basically to prevent this type of potential surface disturbance that could occur, and to prevent the necessity of filing a POO and posting cash bonds for reclamation, UPI's filing format, filed as a NOI precludes major surface disturbances and delineates length of stay by members on our claims. Reference: Your UPI Camping and Mining Rules as spelled out in your Member Guidebook.

NEW DEVELOPMENTS!

The new final rules muck things up even further and nullifies some of the information in Ranger Education. "CFR 228 final Rule is published June 6, 2005". I'm not going to try and explain it in this publication; it's better, in certain respects, than the interim rule, but not much. It appears at first glance that the FS has succeeded in getting suction

dredges and engine powered dry washers classified as motorized earth moving equipment in the new Rule. These areas need further study which will follow next issue. The USFS only has the authority of Congress to control surface disturbance of public lands under their jurisdiction, as directed by law. Moreover suction dredging, in the State of CA, as permitted in the State of California by the authority of the CA Dept. of Fish and Game, is not a surface disturbance by any stretch of the imagination. It is the redistribution of sub-surface stream bed materials. None-the-less you are still going to be required to protect yourself from potential prosecution by the State of CA to purchase a CA Standard Dredge Permit if you suction dredge in public lands administered by the FS. You can view the entire rule by going . On the browse waterfall select Title 36 and click. On the next page select browse parts 200-299 and click, next page select 228 and click, and you can see the entire rule.) There is a analysis of the rule in the July issue of ICMJ that points out pluses and minuses, but leaves to much up to the local ranger. The complete rule with more analysis will follow in next issue of this newsletter.

ELECTION CENTRAL

Changes in the sample ballot occurred as well. President Don Siegel

was nominated for President and accepted. Christa Eastland, Carol Eastland and Denise Matula also accepted nominations for Director positions

In addition to these changes taking place, the Board recommended that some changes take place in the Organizations nominations/elections/voting processes. The proposed changes in the processes are below, and will appear on the ballot for your vote.

This is a no "chad" pen, pencil voting process only. Please mark your ballots clearly. We do not have the time or money to take gripes to the Supreme Court.

LEGAL NOTICE

The Board of Directors of UPI has proposed the following Bylaw change(s) in the Nomination/Election process so that all members of the organization can have their say/vote in who runs the Corporation, not just members of the Corporation that attend the Board Meetings/outings.

Proposed changes are italicized.

ARTICLE IX ELECTION OF OFFICERS/DIRECTORS

SECTION 1. Elections shall be held at the scheduled meeting in October.

SECTION 2. Nominations:

- A. At the April or May meeting a nominating committee of three (3) members one (1) Election committee person, who will chair the committee and two (2) members shall be selected in the following manner: Election committee person appointed by the President and two (2) members selected by the general membership.
- **B.** The duties of the Election/Nominating Committee shall be to solicit and nominate one (1) or more candidates for each elective officer and/or Director vacancy and report to the members at the July meeting.
- C. The Election/ Nominating Committee shall present a proposed slate of nominees at the July general membership meeting. Members present in good standing at such meeting may make additional nominations. The Committee shall then forward its report together with any additional nominations from the floor to the Editor-in-Chief for publication in the next newsletter.
- **D.** No nomination will be accepted without approval from the member. **SECTION 3.** To be eligible for office a person shall be a member in good standing for one year or more at the time of the election.

SECTION 4. Terms of Office

- **A.** The terms of office shall be two (2) years.
- **B.** The President, Secretary, and five (5) Directors shall be elected in odd-number years (2003, 2005, etc.)
- C. The Vice President, Treasurer and five (5) Directors shall be elected in even-numbered years (2004, 2006, etc.).

SECTION 5. Election Procedures

The election of Officers shall be conducted in accordance with the procedures outlined in Roberts Rules of Order.

Article IX, Section 1, shall be amended as follows:

SECTION 1. ELECTIONS

- A. Elections shall be held at the scheduled meeting/outing in October.
- B. Absentee ballots shall be accepted for the scheduled meeting/ elections in October.
- C. Absentee ballots must be received at the mailbox of the Chair of the Nominating Committee no later than 14 days prior to the scheduled election date to allow time for verification of member status or they will be discarded.
- D. Ballots from expired or other unqualified members will be rejected.
- E. Absentee ballots must have the absentee voters UPI member number on it and must be signed by the member too be valid. Spaces will be provided.
- F. The absentee ballot will be first class mailed, or e-mailed to you, upon your timely request for such, by phone, by land mail, or e-mail, approximately one month before the scheduled Election. To use the absentee ballot, refer to the above. Place your postage stamp where indicated on the ballot and mail.
- G. Write-ins will be accepted on Election Day with the member's authorization and check of membership status.

Article IX, Section 2, shall be amended as follows:

SECTION 2. NOMINATIONS.

D. The cut-off date for Nominations from the floor will be at the last Board Meeting prior to the election date.

If these proposed changes are voted in at the October outing/meeting they will go into effect beginning in 2006.




