This is the next step in the environmental review process prescribed by the California Environmental Quality Act (CEQA). The release triggers a 60-day comment period during which agencies and the public are encouraged to review and comment on the document. A copy of the report is available at <u>www.dfg.ca.gov/suctiondredge/</u>. Please send your comments forward by April 29, 2011. Also, see page 10 for a schedule of the public hearing dates.

Finally, some good news! Senators Atkinson, Hass, and Bates who introduced SB 765 to charge out of state dredgers \$2,500 for a permit in Oregon have withdrawn the bill. Thanks to all who helped by writing and calling these Senators. In addition, Senator Ted Gains, R-Roseville, CA has introduced a measure (SB 657) that would repeal the statewide ban on suction dredge mining in California until a full environmental review has been completed. Senator Gains has stated that "It is irresponsible to impose a one-size-fits-all ban on suction dredge mining before we even know what the effects are. There is no scientific evidence that points to suction dredge mining as a cause in the collapse of fish populations. An economic impact report has been started, but there seems to be no urgency in its completion. In the meantime, local economies are suffering and those who depend on the mining to

make a living are impacted". Senator Gains further stated that his measure "will ensure the viability of this industry until there is concrete proof that it does more harm than good. The disruption of an entire way of life for some of my constituents is not something that should be done on a hunch". Please join me in calling and writing Senator Gains to show our support of SB 657 (916-783-8232, 1700 Eureka Road, Suite 120, Roseville, CA 95661). January 22, 2011 Manteca Meeting UPI Minutes

Meeting called to order at 11:00a.m. Officers Present: Don Siegel, President; Ed Ozga, Vice President; Aaron Matula, Treasurer; Rita Perry, Secretary Directors Present: Ron Coleman, Claims; Dave Williams, Membership; Jim Madden, Publisher/Editor in Chief; Terry and Debbie Moore, Outing Coordinator Members Present: Terry Schoen, John and Cathy Meling, Laurie Ozga, Claude and Linda Moore, Bob and Georgia Azbill, Chris Perry, Denise Matula, David and Darlene Norman, and James Neeley Dave Williams, Ed Ozga, and Aaron Matula took their oath of office. Ron Coleman made a motion to accept the minutes, Linda Moore seconded the motion, the motion carried.

Treasurer, Aaron Matula: Aaron is dealing with the IRS regarding taxes that we may owe the Federal Government. We are Tax Exempt with the State of California but we are not with the Federal Government. He is working on getting this resolved so that we are considered a non-profit with the Federal Government as well. The State will be electronic next year. He is hoping to get everyone on board that is using checks to make sure they send him the receipts. He needs these receipts to prove what was spent not only for his records to be accurate but in case there is an audit. Beginning balance as of 12/31/2009 \$16.581.86 Ending Balance as of December 2010 \$7,908.55 Debbie Moore made a motion to accept the treasure report, Ron Coleman seconded the motion, and the motion carried. Budget was discussed as follows: Claims, \$6,000; Membership, \$1,000; Outing Coordinator, \$1,000; Publications, \$4,500; Wagon Master, \$1,600; Ways and Means, \$2000, Claims, Ron Coleman: BLM was paid their fees that were due. He did find out that we were over paying fees to the BLM in past years. He has not heard anymore regarding the Suzy Q Claim since June. 

Assistant Claims Manager Report

Jim Madden

After walking the small stream I area speeds up and the wake saw a good potential spot along the shore. The rock stuck out sharply from the bank and there into your gold trap eliminating seemed to be a lot of small gravel built up on the downstream side. Setting up the sluice box I worked all the material and cleaned up the shallow bedrock. Cleaning out the sluice and panning produced a small amount of fine gold and a small picker or two. This should have been a good gold trap and I would have expected more from it. Scanning the area again, and imagining the water flow during the spring melt and heavy rains, I could visualize the stream washing new material downstream over the top of the rock depositing it in the low pressure zone.

Looking upstream again I did not see any obstructions that would divert the flow away from this spot. Everything looks good all the elements are there, but they always say gold is where you find it. This spot just did not produce.

So we roll back the calendar a few months to when heavy rains came down and during the snow melt the waterway was a rushing torrent. Looking at it from that perspective the waterway you are looking at today has a different flow pattern than it did months ago.

There is a large boulder in the middle of the stream, you can see water is being pinched between the boulder and the shore where the sure fire gold trap was waiting to catch all the gold.

Visual inspection of your gold trap shows why it was not a producer. Water flow in the

around the boulder enlarges shooting a fast stream of water the low pressure area, any gold small and nuggets were washed quickly downstream. The fast water eliminated the low pressure zone below the rock.

What about the fine gold you did find? The reason for this is a stream or waterway will have varying amounts of flow coming down it changing the drop zones. As the rains subside or the snow melt slows down, the stream flow changes all the high and low pressure zones. Lower water flow alters the dynamics of the big boulder, the large wake going around it shrinks and is far enough away that the low pressure zone returns to the trap and it starts to deposit the smaller particles downstream from the rock. Mind you all of the larger gold that was moving when the waterway was high and fast has already deposited somewhere else downstream in another drop zone. At summer time current flows in this spot there is no longer the force available to keep the larger pieces of gold in suspension and most of the gold coming downstream probably dropped out long ago leaving only the smaller pieces and fines.

There are some who have been at it long enough that they can read the river in the summer and usually come up with a pay streak. Most of us do not fall into that category.

With practice one can develop the skills to do this and increase the chance of finding a pocket or pay streak.

So what do you do to increase your ability to read the stream and find gold? You can sit and imagine all day about what is flowing where and where gold might be hiding. What you think may be happening in some cases may be true but for the majority of the time we are more wrong than right. Sometimes finding gold turns out to be just luck.

Research

Grab your raincoat and camera then go make some onsite inspections during rain lulls or during snow melt. Photograph the area and take videos. Pan the camera on the stream slowly (and this is important), so you can take in the whole picture at a good pace otherwise you will be constantly backing up the scene to catch all the action. Another important tip is DO NOT GO WALKING AROUND WHILE VIDEOING. They will look like the super hero flash was filming while running. All you will see is a blur like the camera was rolling down hill. It can actually make one dizzy trying to watch.

I cannot emphasize enough about slow panning of the camera. I have taken video's of streams or inside a condo to record damage from a tenant only later to replay and find it

I cannot emphasize enough about slow panning of the camera. I have taken video's of streams or inside a condo to record damage from a tenant only later to replay and find it streaked by. Take couple of test videos and replay them on your computer to get a feel for the right speed. Today I did some test videoing on the Billy Goat 1 and watched it at the cabin. The scenes where I panned around the creek or walked a short way were shaky and very abrupt.

After printing the photo's you can mark the areas you watched on the video that looked most promising. Next summer drag along the photos and use them to locate the good spots.

Quite a number of years ago I used a 35 mm camera to photograph the American river near Colfax. It cost me quit a bit in film development and printing but it proved to be very worthwhile. The following summer I located a real hotspot that produced 3 or 4 ounces of gold. Of course gold then was dirt cheap but I got a nice sum from it that paid well.

Organize your data I carry a hand held GPS unit and mark the photo spots. Once home I transfer the Way Points to my National Geographic Topo map in my computer which allows me to name my waypoint. You can also mark the spots in google earth I have never downloaded the photos there but that is also an option. Once I download the photos and video's into the computer I create a folder and name it the same as the way point. This way everything is organized and easily accessed.

As I was writing this a thought occurred to me, put your photos in a ziplock bag and paper clip those to the corresponding topo map.

Now when one of these spots turn out to be a good paying location I can go back into my topo program, create a text box and indicate how much gold it produced. Even put a gold star as a flag to remember hit this spot again next year.

Review

Review your videos and photos several times before summer. Use a marker to circle additional hot spots. Eventually you might want to grade the photos and come up with a plan to prospect them.

I had used these techniques many years ago but now with the digital cameras and video capabilities it becomes very cheap except for the fuel costs to get there.

Additional tips:

Batteries

• Large giga byte memory card **Topo maps**

Make sure you carry in your **<u>pocket</u>** a couple of sets of batteries for your camera.

Today I filmed my way down to the creek and got the exausted battery message when I got to the bottom of the hill and had to hike back to the top in my heavy waders.

Do not guess on how much space is available on the memory card if you already have photos on it you should download them and clear the card. Video's take a lot of memory once it is full your research trip is over. I have a 2 GB card now but am replacing it with a 8 GB so I can hit a few spots without downloading the card.

While in Alaska for two weeks I filled up two 2 GB cards. Luckily the second one filled the morning I was leaving

With all the online maps and computer mapping programs I still rely on good old paper maps.

Gold Is Where You Find It

This is the story of my first visit to the site listed in the GPAA's claims guide as 1 CA70. It was early on a Sunday morning and I was planning to visit this new claim site that I had seen in the claims guide. I judged it as being about one hour away from my house in Pollock Pines. The directions seemed very clear and I figured it should be a snap to find. With my wife Georgia, as navigator and co-pilot we set out to find riches at CA70. I followed the directions as narrated by my wonderful wife and we were nearing the site. I turned off the main road at the prescribed mileage and proceeded down a dirt road. (I use the term "road" very loosely. After the prescribed mileage we looked for the turn off that would take us to the Forest Service marker designated as the X marks the spot in the claims guide.

As an extra measure of accuracy we brought my GPS unit along to help us pinpoint the site. By following the directions and the GPS settings we could get no closer than a few miles away. We needed to go more to the south and east. There were no roads going in that direction anywhere that we could discern. Finally after two hours of trying different roads, (again very loose definition), we decide to go back to the main road and try going more south and east on it. A mere mile further down the main road, (past where the directions said to turn off), there was a nice paved road veering off in the direction the GPS unit said we needed to go. After only 10 minutes of beautiful travel we rounded a corner and saw a Forest Service marker with the proper designation on it. There was a great little pull out next to

the stream and a nice section of exposed bedrock with a fine looking sand and gravel bar in the center of the water. A little ways upstream the water cascaded off bedrock into shallow pools and tumbled over small falls into more pools all laden with sand and gravel. I could just "see" the gold shining in the streambed in the subdued light that filtered through the canopy from above.

While I donned my rubber knee boots, Georgia took her pan and trowel and headed to the sand and gravel bar in the center of the stream where she sat down and proceeded to start panning. I then grabbed my sluice and bucket full of digging implements and headed upstream toward the pools under the small falls.

I found a great spot to set up my sluice and got it positioned just right with a perfect flow and started to look for just the right place to dig up some of that good yellow metal. I didn't even get a half of a bucket of material before Georgia started calling to me to come see if what she had was really gold. So, I set my bucket down next to my sluice and started to walk down stream on the polished bedrock in about eight inches of snowmelt. It didn't take more than a few steps before I slipped and the next thing I knew I was on my back in the eight inches of snowmelt with sand and gravel washing into my shirt, shorts, and rubber boots. Hastily bounding to my feet I proceeded to shake the water and material out of my shirt and shorts. The boots were a lost cause since my socks were soaked now. I sat on the edge of the stream and lifted first one then the other foot to drain the water out of the boots

I didn't bother to take them off since I didn't have a spare pair of socks. I just waded down to where Georgia was. She commented on my joyous celebratory dance over her find and said that I should not have gone all the way under water since I did not know at that time if the find was indeed gold, but, that she did appreciate my graceful recovery. I confirmed that she did have a couple of nice flakes in her pan. Then I excused myself and headed upstream to finish gathering material to feed through my sluice. As I limped up the stream I could feel sand in my shorts doing exactly what sand does. There was also a generous helping of Sand and stones in my boots. At this point all I wanted to do was sit on a rock and feed my sluice. I dug up enough sand and gravel to fill my bucket about three fourths full and found a somewhat comfortable rock to sit on while feeding the material through my sluice. The sand in my shorts made every move a new experience. I had nearly forgotten about the sand and stones in my boots when, again I heard Georgia call out that she had found more gold. Would I come and put it in the vial with her other flakes? Not being one to begrudge a fellow prospector a bit of good luck I slowly waded down-stream to see her latest find. Again, she had a couple of nice flakes. One was larger than the first couple together. After picking the flakes out of her pan and congratulating her on her luck, I headed back

upstream. The rocks in my boots were really starting to dig into my feet. I got back to my sluice and noted that there still was no shining yellow metal staring up at me from the black ribbing. I settled down on my rock and started once again to feed material into my sluice. I watched intently as the material washed through the riffles and out the other end. I was more than half way through the bucket before I saw anything stick in the rubber ribbing at the lead end of the sluice. I stared at the little fleck of yellow as I fed more material in and it did not move, and I was pretty sure it was "color".

Georgia called me back to her sand bar one more time to pick some more flakes out of her pan. I still had not emptied the stones out of my boots and they were poking into the bottoms of my feet with every step. I told her, I think I am going to finish up my bucket then clean up the sluice, as I was not having much luck and my feet were getting sore.

I waded back upstream to my sluice and finished running the rest of the material through it and then cleaned it up. I found one small flake in the black rubber ribbing and saw there was a good measure of black sand in the carpet as I washed it out into the bucket. As I said before, I don't begrudge another prospector a little luck in finding a good amount of color. But, when the other prospector is your wife it can be a tender subject, almost as tender as my left foot was getting. As I carried my sluice, bucket and assorted digging implements back to the vehicle one of those rocks was making a pretty good dent in my big toe.

Jokingly, Georgia suggested I empty my boots into her pan to see if she could find any more gold. That is just what I did, and sure enough she did. She held up a pennyweight nugget that dropped out of my left boot.

Well, she had that nugget made into a stud earring and I wear it now to remind me to listen to Georgia, because when it comes to finding gold she is tops.
