


## **THANKS SO MUCH**

#### More on Bull Creek by Prospector Anonymous - 2015

Things that I've learned at Bull Creek UPI Claims - My last article spoke a little about Montgomery gulch and the possibilities of finding something on your own. I hope I didn't mislead any of you on an event you will not want to do again, anytime soon. If nothing found, try again with what you learned from the first time.

The middle UPI claim boundary starts where Montgomery Creek empties into Bull Creek. There is a nice campsite and parking for about five vehicles and a path going up the creek just on the other side of the bridge and across the creek. This part of the claim always floods during the hard rains of winter, so it has a few good spots to get real nice flood gold in the gravel areas. Walking up stream on the east side of the creek at about 75 yards the trail crosses the creek to the west side and this seems to be a good area to prospect for gold after winter flooding. Still walking up stream you'll come to an area where the middle claim ends. At this spot a few years ago there was a large log jam that created an area that the creek had to flow over or around the jam and last year I noticed it had been blown out by high water, this would be a good area to dredge or work and you might find some nice flood gold. Another person has claimed about 1500 feet of the creek before the UPI upper claim starts. The canyon seems to widen here. If you want to climb down from above the road you might need a good climbing rope or make a path to get down to the creek. Making steps and carving your own trail down will let others know and be following in your footsteps, so make very little disturbance to conceal your trail.

As you explore the upper UPI claim you might notice that there are places that were worked with a dragline. Most of the tailings will be on the east side of the creek and this leaves lots of areas to hunt where most people haven't been in a very long time. I've been looking at this area for new prospect holes to reach bedrock because it is shallow in most of the upper area. Not much in the way of prospect holes have been dug in this upper area of the creek. Some dredgers, but not much else to show that there has been a lot of active mining. You might do well to search around and find a spot that could be worth packing equipment in to get the gold. The east side of the creek has a lot of ground to search, because the berry bushes have hidden most of the past dragline attempts to get at the gold in the narrow parts of the canyon and should be explored for new places. Not sure if you have noticed as you drive into the Bull Creek area from below, there is a ranch that is at the bottom of the Bull Creek bridge. This is where all of the creek tailings ended up in the meadow and you can see that there must have been a lot of rocks from the creek that ended up downstream and the original path of the creek has been covered so it is impossible, without some drilling, to find where the old creek bed was long ago just past the bridge. Did all of those rocks come from the middle and lower part of the creek? I only ask because there's not a lot of rocks up stream that didn't make it down that far or maybe there weren't that many to begin with? Maybe the gold was larger, but not as much as the nuggets and fines that were found down in the lower parts of the creek. It will never be known because of the lack of record keeping of so many that may have been before us. Might be time to get out of the creek and look above for more clues to understand what I may be missing.

Time to focus on the areas that might hide some higher gravel benches. There's some very interesting bedrock in this area that isn't like down below. In places it seems to follow like it was moving with the flow of the creek during a cooling period when it came to the surface. It has a ripple looking effect and Montgomery Creek has something of the same looking ripple and blow holes. There are quartz stringers in the bedrock that contain gold, but it is random. And the usual precautions still apply here, water, food, partner, the rest is up to you. **Be careful out there! Prospector Anonymous**







