



Mormon Crickets, which are really not crickets, belonging instead to the family of katydids & long horned grasshoppers, have descended upon Utah with a vengeance. Pavements are covered with them making driving hazardous. All windows must be kept closed or they'll come in. They not only eat up crops but each other if they get the chance. They've also been seen eating the carcasses of snakes & rabbits until nothing is left. Its alleged certain area's water supplies have been contaminated by them. Farmers tried to control them by turning turkeys loose to feed but the crickets ate the feathers off the turkeys. Utah Governor Mike Leavitt has called it the worst infestation in 60 years with 18 of the state's 29 counties declared disaster areas. The worst is not yet over. People, animals & crops are suffering, livelihoods are being destroyed, a species is running amok & the agencies who are to aid in protecting people and their property is so frightened of these so-called envido nothing. They'll pull out all the stops to go after a detectorist digging Ron Stockman a small hole on public lands or a gold MLRC hunter looking for golden flecks but when an entire state is facing ruin, they stay in their offices.

For years groups such as MLRC did everything within our collective powers to have the agencies remove dead & dieing timber, bug infested sectors spreading from region to region destroying our forests. Certain environmental groups filed appeal after appeal along with using threats to stop these harvests. sense doing it.




