



Oath of Office was taken by Don Siegel, Chris Perry, Bob Azbill, and Rita Perry

Bill Reboin resigned as Director.

Steve Letlow will be in charge of the Election Committee, Georgia Azbill and Rita Perry will help.

Minutes: Bill Reboin made a motion to approve the minutes, Tom Eastland seconded the motion, motion carried.

Treasurer, Aaron Matula: Aaron submitted an Income and Expense Report to the board. Beginning Balance 12/20/2006 was \$14,455.11, \$15,806.97 withdrawals throughout the year, deposits of \$17,363.00, which left an Ending Balance 12/19/2007 of \$16,089.14. As of December 20, 2007, there is a balance of \$16,089.14, with deposits \$3,050, withdrawals, \$121.64 left a balance of \$19,017.50. Motion was made by Rita Perry to accept the Treasurers report and seconded by Tom Eastland, motion was carried.

think that Contra Costa Chapter is one of the best Chapters out there. We think they are doing a marvelous job and use them as an example on how they continue to grow and keep their members coming back.

Claims, Chet Chastain: Chet could not make the meeting but sent his report through the email. He is submitting his expense report and wanting it to be approved. The expenses per his year to date report total reimbursement for 1/13/07 \$34.32; 6/2/07 \$4,033.67; 8/4/07 \$60.62; 10/6/07 \$36.67 these were actual check amounts. Including in his report was year to date description of all supplies, postage, printing/copies, telephone, miscellaneous, county property taxes, filing and recording fees, mileage, claims purchased, also prepaid/drawn down amounts. Tax excess pre-payment for 2006 property taxes of \$9.74 was taken out of the 1/13/07 report and is excluded. Prepayment of \$4030.00 was paid by Don at Bull Creek. Gas mileage is 44.5 cents per mile. It was discussed to auction off Clippership. You have to be present to bid and to win. The rules will be released. He has sent out the Plumas, Klamath, and Stanislaus National Forest NOIs. He would like a budget as well. All members at Stanislaus NF (Bull Creek) NOI is needed. Klamath NF (Salmon River) Closed, Plumas NF, CLM Gold still has a special season for dredging, Genesee I is still partially restricted, and he is assuming there may be restrictions regarding the rest of Genesee because of the fires last year. Clippership is still closed and a NOI was not submitted. Tahoe/El Dorado NF- Oxbow the claims are closed due to the danger of accessing them and it was decided at a previous board meeting not to submit an NOI. It was discussed to increase the mileage for Chet to 50 cents a mile.
