
Report made by group: AB1032 was vetoed by the Governor. Everyone should follow up with a thank you letter to the Governor.

The NPS has been getting significant resistance in some areas, enough that they have put planned increases on hold in a few parks. These increases are not being announced at the national level, only locally by each individual Park, Monument, or Historic Site. Comment periods are very short and often not very well publicized. Please check with the NPS units near you, or the ones you enjoy visiting, and find out what their plans are. A spreadsheet showing all planned increases through 2009 is available from the WANFC on request. Then comment to the NPS and send copies of your comments to your elected officials in the U.S. House and Senate and ask them to intervene. Opposition from local governnewsletter. Try and attend the January 12 meeting. Your input ments and Chambers of Commerce has also been proving to be effective in stopping (temporarily) some planned increases. Your efforts can help keep OUR National Parks, Monuments, and Historic Sites accessible to all Americans!

BILL BRINGS BACK FREE ACCESS TO PUBLIC LANDS Baucus, Crapo Introduce RAT Repeal By Bill Schneider, 12-06-07

As promised in an April interview with NewWest.Net, U.S. Senator Max Baucus (D-MT) will introduce a bill on Mondayt to repeal the Federal Lands Recreational Enhancement Act (FLREA), called the Recreational Access Tax (RAT) by its

"It's time for the RAT tax to go," Baucus told NewWest.Net in announcing the upcoming legislation. "Americans already pay to use their public lands on April 15. We shouldn't be taxed twice." 

#### <u>H.R.2262,</u> <u>Hardrock Mining, Royalties</u>

Recently I have been asked a few times about my opinion on H.R.2262, the "Hardrock Mining and Reclamation Act of 2007. Nick Rahall, (D) W. VA introduced this oppressive bill in the U.S. House of Representatives. Having not read it when asked if

I had an opinion, I couldn't respond. I started reading it, 50 pages long, and trying to follow what it was saying, a lot of see section - - . After battling with it and making references and notes for an hour I called PLP (Public Lands for the People) of which I personally am a member and talked to Jerry Hobbs, President. We talked for an hour about a number of different mining issues including H.R.2262. In the context of our communication we did some personal ear bending as well. It was great connecting with Jerry as we have several things in common. In any case the outcome on H.R. 2262, the reason for the phone call, came to this, along with a little learning on my part on civics. H.R.2262 is legislation that has been introduced/proposed for action in the House of Representatives only. There has been no companion bill introduced in the Senate covering the same areas of proposed legislation. As I understand it with no companion bill in the Senate, the House bill is a dead horse. As I understand it, the two houses have to have similar legislation in each house. If this be the case then the two houses get together, get in agreement with what they want and then they send their product off to the President for him to dispose. So at this point in time, all requirements having not being accomplished, H.R.2262 is essentially dead. Additionally, anything that the Democrats might put together on H.R.2262 would most likely be vetoed. Do not take the current status of this item for a given. Your, our constant vigilance and appropriate action is needed to protect our rights as dictated by the Mining law of 1872 and its amendments. We could be in deep trouble as miners, small scale no less, if the Democrats and their environmental whacko deep pockets non-profit corps get into control at the 2008 elections, or if they decide they want to push the issue. The flip side of this is, they may not want to hurt their bid for control in 2008 by pushing for 2262.

"It's that simple," he said. "There's a good reason people live out here. And that's why I'm introducing this important legislation." Right now, the bill has no other co-sponsors, but typically, the main sponsors formally introduce the bill and then look for co-sponsors. It's likely that other senators will join the effort for sane recreational fee policy on public lands. The Baucus-Crapo bill is entitled, Fee Repeal and Expanded Access Act of 2007. It will receive its number when introduced on Monday. A summary of the bill obtained by outlines its for major objectives:

- \* Repeal the FLREA
- \* Reinstate the fee authorities established by the Land and Wa ter Conservation Act
- \* Reinstate the National Parks Pass System

\* Cap amount to be charged for entrance to national parks As background, the Land and Water Conservation Act (LWCA) of 1965 limited the use of fees on public lands. The LWCA allowed the National Park Service to charge limited entrance fees, but other federal land management agencies could only charge fees for developed recreation sites such as overnight campgrounds.

The legislation would essentially return us to the situation we enjoyed under the provisos of the LWCA. The public has never supported the current fee system and congress has never voted the congressional session and became the law of the land. Since then, federal agencies, particularly the FS, have been aggressively raising existing fees and instituting new fees for enjoying the amenities of our public lands, even charging to drive through our national forests on state highways in some states.

Kitty Benzar, President of the Western Slope No-Fee Coalition, the main nonprofit group fighting RAT, has been in Washington D.C. this past week working on this legislation. In a phone interview with NewWest. Net, she said she has found "tremendous support" from senators and representatives and their staffers for the Baucus-Crapo legislation, even though they haven't even seen the bill. "They have no idea what the Forest Service is doing and has planned, and they are astonished when they hear it," she claimed. "This bill is the most important thing we've done for our public lands in the last ten years, easily". Benzar and the late Robert Funkhouser, who has recently passed away while deep in his fight against the RAT, were the driving forces behind informing the public about the frequent abuses of the fee authority handed to federal agencies by FLREA. "Now, the whole issue is blowing up in their faces," she said. "The Forest Service has even been using fee money to close recreation sites and campgrounds. It's an ugly picture out on our public lands right now." Benzar also said she supported instituting an interim moratorium on recreation site closures while the legislation is being debated. January Board meeting will be the 2nd week in January. (January 12, 2008) Location to be determined. Meeting adjourned! 11:30AM





#### PLP SMALL MINERS ALERT!!!

While at the NWMA convention we were told by Mike Doran, Minerals & Geology team leader for US Forest Service that the FS will be publishing a Notice in the Federal Register sometime this month (Dec), giving notice that the FS is proposing to make major amendments to the FS Mining Regulations at 36CFR228. There will be a 60 day comment period, beginning on the day of Fed.Reg.Publication. I asked if there will be any public meetings, and was told none are scheduled as of yet, and that it would depend on the comments they receive. I take this to mean that if we (the mining community) want public meetings, we will have to request them. We were told that the FS plans to amend the 228's to be similar to the new BLM mining regs. at 43 CFR 3809. One item mentioned was the creation of new category of authorization, called Members Up For Renewal: 10-15-07-12-31-07 а "BONDEDNOTICE", which would be used for activities not requiring a POO, but still needing a reclamation bond (possibly for prolonged camping? They mentioned that some small-scale earthmoving operations, such as a 1 man backhoe/trommel operation may fit in this category.) The idea here is to keep operations at the Notice level, as they do not require (according to the FS) any NEPA analysis. I would assume they will also add a provision allowing for criminal citations un- chael Zastawny, Rich Neet, Beverly Paul, Sandy Anderson, der 261. Something more to look forward to..... Tom Kitchar

This change in the Forest Service mining regulations will make mining activities on your mining claims in the Forests unaffordable to most small miners. The FS 36 CFR 228 regulations will be requiring Bonds for a Notice of Intent as well as a Plan of Operations for small-scale miners advocate. We need to see you at the outthing motorized such as suction dredging. The problem the way you would like to see it go. lies in the fact that there are no bonding companies that will Bond a small scale mining operation and the bond will have to be a cash bond that most will not be able to afford. We had better get serious about this one and start raising funds now.
