

One Person Can Make a Difference -Support Brandon Rinehart to the Supreme Court http://peoplevrinehart.org/

In San Bernardino Superior Court, Judge Gilbert Ochoa candidly admitted that the mining community is being denied justice in his own courtroom by deferring a decision on the CEQA case. In what amounts to a judicial ole', Judge Ochoa is kicking the can down the road **until the California Supreme Court rules on the Brandon Rinehart case**.

From Attorney James Buchal: This morning (Editor note: 01/20/16) was the scheduled time for Judge Ochoa to hear and rule upon CEQA and Administrative Procedure Act challenges to the Department's FSEIR on suction dredging, as well as the time set for a hearing on a motion for summary judgment (and the Department's counter-motion for judgment on the pleadings) concerning the question whether AB 120 and SB 1018 were unconstitutional for violation of the "one subject" rule in the California Constitution.

The hearing was delayed because the Judge was in the process of preparing his tentative ruling (poor quality camera copy attached—I'm still at the airport): he would not decide anything; everything would be stayed pending a ruling in People v. Rinehart. I was given the opportunity to contest the tentative ruling, and pointed out to the Judge that while there was some limited overlap between the federal preemption issues and the CEQA arguments, the "one subject" case had nothing to do with People v. Rinehart.

I explained that we were in the process of getting water quality permits or waivers, but even if we got them, the unconstitutional provisions of AB 120 and SB 1018 would still require certifications about birds, noise, wildlife and historical/cultural issues, such that we could not get suction dredging permits even to run under the restrictive 2012 regulations. Striking down AB 120 and SB 1018 would remove all legal obstacles (other than water quality certifications) to the Department's issuance of permits under the 2012 regulations without regard to any federal preemption issues. I was interrupted in mid-argument as I then strayed into the merits of the CEQA baseline argument (which also has nothing to do with federal preemption).

At the end of the hearing, after hearing from the Department, which reversed its earlier position that we needed to decide these issues, I said that of course the Department and Tribe were happy for delay, that justice delayed is justice denied, and this was unfair. The Judge remarked that he agreed with my last observation, it was unfair, but there was nothing he could do about it.

Whether or not a federal court will recognize the extraordinary nature of our treatment in the California courts as, in substance, a concerted effort to frustrate federal civil mining rights, remains to be seen. This morning's developments are certainly more evidence in support of that position.

Questions About On-line Sign Up & Renewals

As many of you know the board has been asked repeatedly to look into accepting credit card payments on-line or the possible use of PayPal for new memberships and renewals.

We recently took a closer look into this topic and discussed various challenges with our Webmaster. Offering online payments would be a nice "convenience" but, we first have to look at the inner workings of the organization, and our efforts to keep costs to a minimum.

In this day and age, it is common for folks to think of online payments as routine for all transactions, but as we found, each transaction would come with a 2.9% fee plus \$0.30. That cost would have to be absorbed by our non-profit organization. Then there is the ever-present risk of online identity theft that could open the organization up to an expensive risk that we are not equipped to repel or litigate. PayPal was in the news just last August with stories of concerns over security vulnerability issues.

Another concern is that online payments would not ensure that we have the SIGNED renewal/release form on file for each affected member. Also we would have to come up with new processes to confirm payments and match them to members before sending out new packets and membership cards. To accommodate such a process would require multiple changes to the website and additional cost for web security. This is beyond our current means and level of expertise.

In summary, the cost, security risk, time, and size of our organization currently can't support a change of this kind.

We can't tell you enough how much we appreciate your ideas and suggestions, so please keep them coming. While, we, the Board, administratively keep the organization going, we are all responsible for its continued success.

IMPORTANT REMINDERS

As a UPI member you have access to over 1200 acres of UPI claims, so there is room for everyone. However, please keep in mind that every person working a UPI claim must have a UPI membership. The only time a guest is permitted to work a UPI claim is during a scheduled outing and only when assisting you. Guests must sign a Guest Release of Liability and Assumption of All Risks, a copy of which is available in you Membership Claims and Rules Guide Book or at our UPI website.


We had 15 members renew in January. Thank you for your continued support of UPI. It's always great to see so many friends stay active and continue to support our organization.

BOARD OF DIRECTORS MEETING

January 23, 2016 - President called meeting to order at 11:35 a.m.

Roll Call –

Officers present: Don Siegel, President; Ed Ozga, Vice President; Aaron Matula, Treasurer; and Dolores Sauls, Secretary Directors present: Dave Williams, Membership; Mike Hammond, Claims Manager; and Laurie Ozga, Publisher/Editor-in-Chief Volunteer's Present: Bob Azbill, Wagon Master Members present: Denise Matula and Georgia Azbill

Vice President, Ed Ozga, swore in Don Siegel as President, Dolores "Dolly" Sauls as Secretary, and Laurie Ozga as Editor/Publisher-In-Chief. Motion was made and passed to accept the minutes of the last meeting. **Treasurer –** Aaron reported there is \$3,176.39 in the bank. A motion was made and passed to accept the proposed budget for 2016. A motion was made and passed to pay the outstanding bills. The treasurer was congratulated on how good the budget report looks.

Vice President – Ed had nothing to report

Chapter – Ed reported that Joyce will start up a "UPI Central Valley" Chapter in Stockton, CA. Meeting room located at the American Legion Building . This chapter will meet every 2nd Tuesday of the Month (*Editor's* note: Since the Board meeting date was confirmed to 2nd Wednesday of each Month). First Chapter meeting will be announced. Board and Contra Costa Chapter committed to supporting Central Valley Chapter kick-off with membership attendance, first meetings "rent", and raffle prizes. Estimation is no more than 10 (4 Sonora, 2 AMRA and 2 ?) There was a discussion to keep track of how many of Free Memberships actually renew their membership. Discussion was held regarding if we want to do Sonora Gold Show Membership Drive again this year. In addition, Ed proposed for us to do a membership drive at the ICMJ Placerville Gold Show on April 16th and 17th of this year. Don will call Sally about reserving a booth for the Placerville Gold Show and he'll talk to Jay about reserving a booth for the Sonora Gold Show. (Editor's note: Post meeting, ICMJ Placerville

show is full and we are on waiting list. Our booth at Sonora Gold Show is confirmed). UPI placed an ad in the ICMJ which, to date, has resulted in 2 new and 3 prospective memberships. For the cost of the ad it did not seem beneficial to renew the ad in ICMJ. A suggestion was made to put an ad in our newsletter that we're in the ICMJ! Emails sent to members to remind them it's time to renew 30 days prior to expiration date is working well. Dave and Mark were congratulated on what a good job they are doing with membership emails.


