

President Don Siegel called meeting to order at 10:07 a.m.

#### Roll Call:

Directors Present: Bill Reboin, Chet Chastain, Brenda Marsh, Steve Letlow, Tom Eastland (dual role), Don Siegel (dual role), Linda Doyle, Gerald Hurt, and Aaron Matula.

Members Present: Chris Perry, Christa Eastland, Beverly Paul, Aaron Matula and Mark Weber.

Minutes were read and changes are as followed:

September 9<sup>th</sup>, 10<sup>th</sup>, and 11<sup>th</sup> Outing will be at Greenhorn.

Steve said that on the survey on the web page 4 to 6 outings got the biggest number out of the percentage of 100 responding people. Gerald Hurt handed out a sample letter that could be used to withdraw Notice of Intent signatures from the Forest Service.

Motion was made by Linda Doyle and seconded by Chet Chastain to accept the minutes from our last meeting. Motion carried.

- Treasurer, Samantha Wait: The checkbook balance as of January 21, 2005 is \$9,258.99; total revenue \$1,516.00 which leaves a total of \$10,774.99. Administration Expenses: \$807.66; Claims Expense: \$869.22; Legal Fees & Taxes Expense: \$500.00; Publication Expense: \$1,090.51; Ways & Means Expense: \$29.53; Total Expenses \$3,296.92. March 11, 2005 Balanced Checkbook is \$7,478.07. Motion was made by Chet Chastain and seconded by Linda Doyle to accept the treasurer report and motion carried.
- Membership, Linda Doyle: She has been working on the totals of comparing 2003 to 2004 as to non-renewing members. 2003 we had 125 that did not renew, 2004 we had 128 members. Will be working with Chet in writing a letter to the non-renewing members a letter by mid-April at this point 253.
- Wagon Master, Steve Letlow: We had a sit down with the Forest Service in Forest Hill to get our permission for the Oxbow Outing. Gerald will be explaining this. We are still trying to get Oxbow and Chet will explain this. All six bathroom-facilities were open last weekend March 5, 2005 and he wants us to be aware of this when we go April 9<sup>th</sup> to see if all the facilities will be open or just two that he requested. There will be no mining at Oxbow according to the Forest Service, but we can have the Outing there.

She is looking at possibly doing survivor skills and doing a 1–2 hour presentation for adults and children at these different outings. Have instructional presentations regarding panning, sluicing, dredging, etc. Also, there was discussion regarding lapel pins for members. Rita and Samantha will not be at the Oxbow Outing.
- Ways and Means, Don Siegel: Ways and Means has been a position that he has carried for a while and there has not been any activity in that position except for to talk to a few people in regards to a few people in taking over the position. 

# **OXBOW CLAIMS RELEASE** THIS IS MUST READ AND FOLLOW

The map entitled "Oxbow UPI with restrictions" is in effect until May 10, 2005. Due to the proximity to the power house and the dam it was necessary to file this portion under the "PL359" restriction. PL359 is basically a release of BLM liability regarding the possibility of limited mineral extraction.

In this particular case, it has to do with the restrictions of digging around the dam and powerhouse. We obviously do not want to undermine these structures. Under PL359 no mining can take place for the first 60 days after filing with BLM. We filed on March 10, 2005; therefore the 60-day window will lapse on May 9, 2005. Please observe the restriction by not panning, digging or otherwise disturbing this area. by the FS in an effort to circumvent/nullify the Mining Law of 1872. Please see the two maps below of the new claims at Oxbow. We can mine everywhere except the shaded area, indicated in the restricted area shaded area actually appears as the area that is devoid of any kind of markings at all and is the area that we have been normally mining for the past number of years. The other map shows the entire claim area, again the shaded area, though nor shown, is possibly subject to some restrictions as determined by BLM. We'll know about this on May 9th.

A little history: UPI has been meeting and mining at Oxbow since 1986 that I am aware of, and have documentation of. As it is understood there was a withdrawal of the area in 1953. 
the last five years Guidebooks.) Current information indicates that not only was Oxbow an open area to mining, but an open area to claim. Which is exactly what UPI did with information obtained from BLM after a meeting with the FS people at the Foresthill office of USFS to obtain permission to camp at the site. It is OK to camp, but Tahoe National Forest denied the right to mine. Looks like we may have trumped them, the FS, we'll see how this plays out.

It is understood that by me once the PL359 process is satisfied, if BLM doesn't place stringent restrictions on mining what we know as Oxbow, the shaded area, the Forest Service cannot prevent us from mining there. If they try the burden is on them, they must site the laws/rules. Of late they haven't been very successful in restricting mining/camping on legal claims. They lost Lex-Waggener late last year, and just recently lost the McClure case, a Salmon River dredger. In both of these cases, PLP played a part in helping the defendants win their cases brought on

These are our first claim filings in which UPI is not going to file eicontrol the miner(s) that is not a requirement of the Mining Law of 1872. The only time a NOI needs to be filed is if there is going to be significant surface disturbance, tree cutting and or the use of earth motorized moving equipment. (Back hoe, bull dozer etc.) And only if there is going to be a really significant surface disturbance does a POO need to be filed.

It should be expected that we may be visited by the Forest Service map, within the regulation limits (such as dredging season, etc.). The over the course of the outing. They have visited the last two outings. Last year they were a little pushy. So be prepared, as it is probably a good chance that they will be there and try to stop mining activities on our claims. We will not be mining on the restricted area. We will be mining only on our legal claims. There will be no tree cutting, use of motorized earth moving equipment hence no significant surface disturbance. No need for a NOI, though they may argue this and threaten. The best thing to do in this case is to be pleasant with them and comply with their wishes. In doing so be sure to get their name, badge number, whom they represent and a copy of the rules/laws that it is alleged we/you are breaking. If they cannot supply you with a copy of the rule/law, politely reyour pack. This information will go to PLP At all times be polite and remember we are a small-scale mining organization, not a club.

If you don't know your rights, you loose them. We are taking a stand





This is the area that we have mined historically. We must wait for the PL359 process to run and see its outcome before we may be able to mine it. It is strictly off limits to any kind of mining over the outing and until the PL359 time is up.

You can mine anywhere else within the boarders of the claim map. You will have to perhaps do some boulder hopping or wading to get to these parts of the claim that are open to mining.




### Subject: Death Valley

### **INTERESTING FACTS ABOUT GOLD**

In 1799 a 12-year-old boy named Conrad Reed is believed to have found one of the very first gold nuggets in the United States. His family used it as a doorstop until a jeweler bought it for \$3.50. Not a bad price, considering it weighed 17 pounds and was actually worth about \$4,000 at the time.

The average gold content in the earth's crystal rocks is about 0.005 parts per million (ppm) and in seawater at about 0.000012 ppm.

Do you know what one atom of gold weighs? One atom of gold weighs 

Did you know that one (1) gram of gold contains 305,760,000,000,000,000,000 atoms of gold!

Did you know that one (1) ounce of pure gold contains 9,510,200,000,000,000,000 gold atoms!

250,000,000 atoms of gold placed side-by-side would make a line approximately one inch long!

At a price of \$270 per troy ounce, it would take 350,000,000,000,000 atoms of gold to equal a value of 1 cent!

Gold can be worked into a layer measuring 1 millionth of an inch.

One ounce of gold can be stretched into a wire more than 40 miles long!


There are certain acid and alkaline compounds that will dissolve gold. The best known is *aqua regia*, a potent combination of hydrochloric and nitric acids.

The total amount of gold ever mined is approximately 3.8 billion ounces. More than half of that has been mined since 1850.

If all the gold mined over the last 6,000 years were gathered and melted down, it would form a cube with sides of no more than 20 yards.

Gold is completely recyclable. In fact, nearly all of the gold found during the past 6,000 years is still in use. Think about it, the gold in your wedding band or watch could have been mined by the ancient Egyptians, plundered from the Incas, or panned out by one of the original 49'ers - you never know!

Gold is a good conductor of electricity and is the most malleable and ductile of all metals. Gold's most important use is in computers, weaponry and aerospace. It is used where consistent, reliable performance under all conditions is essential. The electronics industry has tried to find substitute metals and alloys, but gold's exceptional resistance to corrosion and tarnish is still unequaled. This durability accounts for the almost perfect condition of coins and artifacts fashioned from it thousands of years ago.

Who is Jack Blackwell other than a Ranger in

charge of a lot of area? A civil servant hired to uphold the law, not make the law. He can make his recommendations, but he has no authority to make law, which he has allegedly done by issuing the alleged memo that a suction dredge is to be considered as earth moving equipment. Lets dissect this a little bit. First off the USFS only has control over

surface disturbance in "our forests". Suction dredging is not a surface disturbance activity. It is a subsurface disturbance activity, where-in subsurface waterway materials are moved from one position on the streambed to another, usually within about 20 feet of each other. During the process the materials are directed through a classifying/separation process to separate out high specific gravity materials, gold for one, from the lower specific gravity materials, the streambed sand and gravels.

Two: The State of California Department of Fish and Game (DF & G) is the legal entity that issues standard suction dredge permits in the State of California, not the USFS. DF & G has established what, when, where, how and why you can suction dredge in all of the California waterways and hydrological units with minimal deleterious effects to the waterway bio and the hydrological unit. Moreover the DF & G has established that by following the terms of the Standard Suction Dredge Permit, that the waterway habitat is enhanced.

Suction dredging done by the terms of the permit, loosens naturally compacted, caused by water flow, stream gravels, and loosely redeposits them in the streambed. This enhances the creation of spawning beds of various specie of fish by loosening up the gravels so that they may create a spawning bed, a place to lay their eggs. Also, suction dredging done by the terms of the permit does not allow undermining of stream banks whereupon with a high water event the surface will not be disturbed and cave in changing the surface structure.

So what position does this put the USFS in, what is their real intent? From their activities one has to believe that there may well be a conspiracy within in the USFS to close down small-scale mining by intimidation. This done by threatening miners that are operating within the confines of the various regulations, and citing them with a non-applicable rule/law so they have to appear in court. This was the case with two recent cases that we all should be well aware of. The USFS lost those cases because both of the defendants choose to fight for their rights. Might it be that the USFS is hoping that miners caught in that situation might just appear in court, pay their fine and cease and desist, give up? One might have to think that, especially with the CFR 228 hanky panky going on. (If you desire back issues with information on CFR 228 they can be down loaded from the members only area of the website. Or you can request that the Ed/Pub print you an issue. The cost for this would be \$5.00)
