







Directors Absent: Don Williams and Rod Earnest.



Motion was made and seconded to accept the minutes from our last meeting after corrections.

- Treasurer, Leland Brown: The checkbook balance as of 10/12/01 was \$4,929.04. Income was \$1,817.50 and total expenses were \$6,164.32. Motion was made to approve, seconded and approved to accept the report. Bills were presented; a motion was made, seconded and approved to pay the bills.
- Membership, Don Riley: As of the Oct 13th there were 381 regular members, 42 life members, 15 complimentary members, 2 honorary members and 5 advertisers for a total of 445.

WE DIG IT By Tom & Phyllis Malicki

I was born in the U.P. (AKA as the Upper Peninsula of Michigan) and this area is known for its rich



mineral deposits, even *gold*. In the 1880's small mining operations produced \$650,000.00 worth of gold and silver and some mines produced rich specimens of gold bearing quartz. Recreation stream panning is all the prospecting that is being done today

Copper was one of the major ores and the Keweenaw Peninsula is called "Copper Country". Aboriginal people used copper as far back as 7,000 years ago to fashion tools and weapons. White explorers discovered the vast copper deposits in the mid 1800's and created an economic boom for the area.

The copper is in very large solid masses and difficult to mine. There are still untouched areas of pure ore but it became too costly to compete with open pit operations and the last mine closed in early 1990. Fine specimens of silver and copper, called half-breeds came from these mines and are highly prized by collectors.

"17 ton copper slab lifted from the floor of Lake Superior." This is the headline of a newspaper clipping sent to

me by my brother last month. 18 feet long, 8 feet wide and 15 inches thick. However when we visited the U.P. last year we saw a photo of a copper slab estimated to weigh over 100,000 pounds. That's a lot of pennies.

Iron ore is still being mined in the U.P. and shipped via the Great Lakes.

The recent tragedy concerning terrorist attacks against our country is fully occupying law -



makers at all levels of government so as to make it impossible to talk to them about anything related to our issues. Because so many fine speakers have already addressed these dark days MLRC has chosen not to add to that which has been stated except to say that we are as shocked and saddened as you over these events. We now live in a new America, an America in which we all have to be alert to what is going on around us. We also realize that citizens will probably be more restricted in their movements but we all must be careful that our basic liberties are not interfered with. Once lost, they are almost impossible to get back. MLRC will continue to work to protect the rights of the citizen collector as well as educating the public on collecting issues.

Over the years MLRC has hammered on certain issues, possibly to the distraction of some in the collecting community. We do so because some points are valid and are central to enhancing the citizen collector's rights. Most of our victories in the past have revolved around providing relevant information upon which arguments can be built.

A major point of contention is the over abundance of common collectibles crammed in government warehouses and the basements of universities around the country. In many areas of archaeology & history the entities have become more collectors and less a science. We realize that some of our critics will say of course we would take such a position because we are

biased. But suppose the same argument was offered by some of the world's most respected archaeologists?

The Biblical Archaeology Review (BAR) is a publication respected around the world. It's contents address some of the most important digs going on today. In the March/April 2001 BAR magazine the following words are found:

"We believe that market forces can be a far more effective tool in combating looters than current laws. Duplicate artifacts, especially common pots and oil lamps, which currently cram government storerooms but add nothing to scholarship, should be sold off. They can be tagged with an identification number in case they are ever needed for future study. Why would anyone buy a dubious artifact on the illegal market when a certified twin can be had just as easily? The bottom would fall out of the illicit market." MLRC could not agree more but we further state the process ought to be extended to the citizen collector who finds common manufacture objects.

BAR further states: "We also believe that many antiquities laws are misguided and counterproductive. Our position has set us squarely against the Archaeological Institute of America (AIA)". "It (AIA) goes so far as to vilify antiquities collectors on the grounds that the collector's acquisitions fuel looting. We too (BAR) oppose looting but are convinced that current laws simply drive the antiquities market underground; they do nothing to curtail looting." Again MLRC agrees. By cutting out the citizen collector through the use of outdated laws and further defaming collectors as mere looters groups such as the AIA merely make the situation worse. In short, their policies make the plans of the bad guys work even better. The truth is, many highly trained archeologists do not see the citizen collector as threat, either to themselves or artifacts. It is only a few but these few have been very vocal although when seriously confronted with logic they tend to tone down.

England has learned some valuable lessons in cooperation. In coming releases MLRC will delve into the English system of doing things with citizen collectors. We hope we can educate enough people to present a solid front for reasonable involvement by citizen collectors. This piece has revealed that some professionals in archaeology feel much the same way we do.






