

BOARD OF DIRECTORS MEETING

June 28, 2016 - President called meeting to order at 6:55 p.m.

Roll Call –

Motion was made and passed to accept the minutes of the last meeting.

Treasurer – Aaron reported there is \$2,533.61 in the bank. A motion was made and passed to pay the outstanding bills.

Vice President – Ed suggested a check list should be created outlining the process for maintaining Claims for new Claims Director.

Chapter – Ed reported the new chapter "UPI Central Valley" in Stockton, CA is going well. President, Don Sigel and Vice President, Ed Ozga, will be arranging a meeting to speak with Gil about his interest to start up a South Bay Chapter in Fremont.

Membership – Dave reported we have 247 total active members which include 65 life, 178 regular, and 4 advertisers. We will be doing a Membership Drive at the Sonora Gold Show again this year. New Members that sign up will receive an extra 3 months of membership for a total of 15 months. This also applies to any current member that renews their membership at the Sonora Gold Show. Dave still has some tri-folds left from last year's Sonora Gold Show that we will be able to use at this year's show. Dave reported that his grand total expenses for this year were \$137. He is running low of Guide Books and needs to print more. He will print as few as necessary, pending proposed changes to the Guide Book.




